4.	Community Partner Updates	Shawn Quigley provided an overview of Youth Diversion services to LDSB for the 2024-2025 fiscal year. Shawn provided a summary of the students supported by Kairos, indicating that 45% were at "medium" or "high" priority for receiving support. Out of 142 clients screened with the GAIN-SS, 74% showed "moderate" to "high" concerns. There has been an increase in moderate to high concern regarding high crime violence, including criminal activity associated with substance abuse, such as stealing and physical assaults.	S. Quigley

5.	Review of 2025-	Adverse Childhood Experiences (ACEs) data is collected. The data reflects all students served, not just those who attend LDSB. 63% of youth had three or more ACEs. 342 had a parent with substance use issues. 8% of youth indicated that they were homeless, living rough, couch surfing, or living with significant others. Mental health issues are on the rise, with clear distinctions between suspected and diagnosed cases. 63% of youth reported school issues, including suspensions and expulsions. Shawn expressed that as a community, we are not effectively reaching families. How do we engage caregivers? We need to stop expecting that they will come to us. We need to go to them. Shawn provided an overview of the upcoming "KFL&A Unnamed Youth Project." The hope is that 200 youth attend the day.	All
