We continue to amplify the voices of Indigenous Peoples as part of our ongoing commitment to Truth and Reconciliation. Laura Conboy highlighted Isabella Kulak from the Cote First Nations in Saskatchewan. Isabella was shamed for wearing a traditional ribbon skirt on "formal day" at her school. 4. Student Census 2025 Consultation	Ellyn Clost-Lambert provided the committee with information about the upcoming Student Census. Ellyn and Laura Gillam are meeting with various groups to build a shared understanding of the purpose of the Student Census and gather feedback about the design, survey questions and implementation. Ellyn and Laura G facilitated a discussion concerning Census questions related to mental health and/or substance use. The Committee discussed whether to include a question on issues affecting well-being, as similar questions are already included in the School Climate Surveys, which are anonymous and offer more protection to students. The goal of the previous Census question on issues affecting well-being was to understand what issues were affecting students in the areas of mental health and substance use. The committee is considering whether there is a need for this specific information to be tied to achievement-related data. Committee members also reviewed the wording of questions related to disabilities and discussed the importance of ensuring language is appropriate for different grade levels. The committee's suggestions were noted and have been included as question options to be taken to other groups for consultation. Ellyn and Laura G will return to the May committee meeting to finalize the questions. 5. Community Partner Updates	Shawn Quigley reported that as of April 2024, there have been 94 new referrals to Kairos. A summary of the Global Appraisal of Individual Needs – Short Screener (GAIN-SS) assessment and survey results has been created, highlighting the frequency of specific substances identified. There is an observed increase in substance use among caregivers. A reduction in opioid use among youth has been noted, attributed to the increased difficulty in accessing prescription medication.
