ADMINISTRATIVE REPORT: MANDATORY E-LEARNING CREDITS EDUCATION, POLICY AND OPERATIONS COMMITTEE MEETING

March 9, 2022

Purpose

To provide the Board of Trustees with an information update related to the eLearning graduation requirement introduced by the Ministry of Education, effective February 1, 2022.

Background

On February 1, 2022, the Ministry of Education issued Policy/Program Memorandum (PPM) 167 which formalized the new mandatory eLearning requirement for students. The goal of this new graduation requirement is to help students develop digital literacy and other transferable skills they need to succeed in school, work, and life.

Current Status

The mandatory eLearning credit was first announced in 2019, beginning with the cohort of students who entered Grade 9 in 2020-2021 (students currently in Grade 10). Students must earn two online learning credits to obtain their Ontario Secondary School Diploma (OSSD), which students will typically take during their Grade 11 and Grade 12 years. Any credits offered online that count towards the OSSD are eligible credits towards the graduation requirement, including credits taken during summer school. Ministry funding was reduced last year on a per pupil basis to align with class size averages, and the expectation that students will take two eLearning courses prior to graduation.

In recognition of the extraordinary circumstances during the COVID-19 pandemic, up to one secondary school credit completed by Grade 9 students during the 2020-2021 school year during the province-wide school closures from April 2021 to June 2021, may be counted towards the new graduation requirement.



Parents and guardians will have the opportunity to determine whether online learning is appropriate and beneficial for their child, and may opt their child out of the mandatory online learning credits.

Limestone District School Board currently offers eLearning courses in partnership with 36 other school boards through the Ontario eLearning Consortium (OeLC). To support the online learning graduation requirement, Limestone District School Board will be increasing our eLearning course offerings next year. These courses will be taught by Limestone District School Board teachers and will be offered to students through the regular course selection process. These online learning courses will be timetabled based on student interest, and offered to LDSB students prior to being included in the eLearning consortium for registration by students in other district school boards.

ADMINISTRATIVE REPORT: BOARD COMPOSITION – INDIGENOUS TRUSTEE

EDUCATION, POLICY AND OPERATIONS COMMITTEE MEETING

March 9, 2022

Purpose

To provide Trustees with a summary of information related to adding an Indigenous Trustee.

Background

At the February 9, 2022 EPOC Meeting, Trustees requested an update related to options for Limestone District School Board to pursue regarding an Indigenous Trustee. In addition, a notice of motion was put forward at the February 23, 2022 Regular Board Meeting:

That the LDSB pursue the appointment of an Indigenous Trustee based on the option through Limestone's Education Agreement with the Mohawks of the Bay of Quinte.

Trustees will remember the information shared with them at the May 29, 2019 EPOC Meeting by then Superintendent Burra. A review of this same information appears below.

Ontario Regulation 462/97 outlines the requirements for First Nations Representation on Boards. One of the requirements is the existence of an Education Agreement with a First Nation, or First Nations, where students from that territory attend a board school. As of September 2018, LDSB entered into an Education Agreement with the Mohawks of the Bay of Quinte (MBQ). Regulation 462/97 provides further details regarding circumstances requiring the naming of a person to represent Indigenous pupils on the board:

- (4) Where the number of Indian pupils enrolled in the schools under the jurisdiction of a board under one or more agreements made under this section exceeds 25 per cent of the average daily enrolment in the schools of the board, two persons may be named under subsection (1), and subsections (1) to (3) apply with necessary modifications in respect of the two persons. O. Reg. 462/97, s. 1 (4).
- (5) Where the number of Indian pupils enrolled in the schools under the jurisdiction of the board under one or more agreements made under this section is fewer than the lesser of 10 per cent of the average daily enrolment in the schools of the board and 100, the appointment under subsection (2) may be made at the discretion of the board. O. Reg. 462/97, s. 1 (5).



Current Status

Currently, Limestone DSB has five (5) students from MBQ attending Napanee District Secondary School. Five to ten years ago, this number has been as high as 15-20 students. Based on the regulations outlined in paragraphs (4) and (5) above, Limestone is not required to appoint an Indigenous Trustee. Based on overall enrolment in Limestone, students from MBQ represent about 0.03% of students.

According to Regulation 462/97, and the current number of students from MBQ, an appointment to the Board would be at the discretion of the Board. Based on our Education Agreement, the Board would need to consider adding a Trustee if we had at least 100 students from MBQ. Given the Education Agreement with MBQ provides the only regulatory mechanism for the appointment of an Indigenous Trustee, MBQ would have to be engaged in the process. It should be noted that Hastings Prince Edward has over 100 students from MBQ and has an Indigenous Trustee that is appointed by the MBQ Band Council. Outside of the Education Agreement with MBQ, there is no regulatory provision for the addition of an Indigenous Trustee.

Under current legislation, Regulation 462/97 is the only option for a school board to add an Indigenous Trustee. As Trustees will remember, in the spring of 2021, Limestone submitted a policy proposal to OPSBA that was approved to ask the government to consider additional options for school boards to add an Indigenous Trustee. Given the current constraints of the Education Act regarding Indigenous representation, Trustees are reminded that they added an Indigenous Student Trustee starting in the 2020-2021 school year.

It should be noted that a decision related to adding an Indigenous Trustee from the Mohawks of the Bay of Quinte is not tied to the decisions related to Trustee Distribution. However, if this option is to be considered, adding an Indigenous Trustee through Regulation 462/97, could be aligned with the upcoming term of Trustees after the next municipal elections in the fall of 2022, or initiated at a different time.

The cost of adding an additional Trustee would be approximately \$15,000. Trustees could choose to fund this additional cost from Governance funding. Adding an additional Trustee to a complement of ten (10) would require a review of current policies to ensure alignment. Alternatively, Trustees could choose a zero-cost option by reducing their compensation by approximately 10% to cover the cost of an additional Trustee, or reduce the number of Trustees allocated on the basis of Regulation 412/00 based on population from nine (9) to eight (8).

ADMINISTRATIVE REPORT: TRUSTEE DISTRIBUTION FOR 2022 ELECTION

EDUCATION, POLICY AND OPERATIONS COMMITTEE

March 9, 2022

Purpose

To provide information on the distribution of Trustees for the upcoming 2022 election and to make recommendations to the Board to ensure compliance with the Education Act and Ontario Regulation 412/00.

Background

Each election year, the Ministry of Education prepares a Trustee Determination and Distribution Guide to assist school boards in preparing the Trustee Determination and Distribution (D & D) Report. A copy of the guide was distributed to Trustees at the February 9, 2022, EPOC Meeting. At that meeting, Trustees also received an administrative report on preparing for the 2022 school board election. The report provided the timeline for the various decisions and deadlines that need to be met regarding the election.

At the February 23, 2022, Regular Board Meeting, Trustees approved the designation of the municipalities of North Frontenac, Central Frontenac, and Addington Highlands as low population municipalities. Trustees also approved that the sum of the electoral quotients for these municipalities be increased by one so that those combined municipalities would receive representation by a single Trustee.

Ontario Regulation 412/00 requires school boards to complete the D & D Report by the end of March in the year of the election and copies of the report are to be provided to the Minister, election clerks of municipalities, and secretaries of every other school board within the board's jurisdiction.

The Board approved an alternative distribution of the nine Trustees to geographic areas within the board for the 2018 election, and they were as follows: Loyalist Township & Stone Mills (1 Trustee); Greater Napanee (1 Trustee); South Frontenac (1 Trustee); Central Frontenac, North Frontenac, and Addington Highlands (1 Trustee); and City of Kingston (5 Trustees).



Current Status

Distribution of Trustees

Guidance on the distribution of members to geographic areas is provided to Trustees in the Ontario Regulation 412/00 made under the Education Act.

The guidance is as follows:

4.(4) In carrying out its duties under this section, the board shall have regard to the following principles:

- 1. Municipalities with low populations should receive reasonable representation.
- 2. Evidence of historic, traditional, or geographic communities should be taken into account.
- 3. To the extent possible, the identification of low population municipalities should permit the establishment of geographic areas that coincide with school communities.
- 4. Representation should not deviate unduly from the principle of representation by population.

Trustees directed staff at the February 23, 2022, Regular Board Meeting to present several alternative distribution models with mapping of schools and wards for decision making purposes. Attached are FOUR options with maps showing the electoral population distribution per Trustee combined with schools and student populations.

<u>Option 1</u>— this option shows the existing Trustee distribution for the municipality of Kingston and surrounding municipalities with the 2022 electoral population and 2021-2022 enrolments.

Option 2- this option details a proposal as provided by Vice-Chair Gingrich showing a distribution by combining wards within the municipality of Kingston while keeping the representation in the surrounding municipalities as per the 2018 election.

Option 3 – this option shows the City of Kingston and Frontenac Islands at large represented by five (5) Trustees with the representation in the surrounding municipalities as per the 2018 election.

Option 4 – this option details an alternate distribution within the City of Kingston and Frontenac Islands by combining wards in close proximity, equalizing the electoral population and student population to the extent possible, and with the representation in the surrounding municipalities as per the 2018 election.



Recommendations








